

Blend4Web SDK Pro

Software License Agreement

This document is a legal agreement (the "Agreement") between Triumph LLC (the "Licensor") and any legal entity or individual, including sole proprietorship (the "Licensee"), that has installed, launched or otherwise used the Software.

By downloading, copying, installing, launching or using the Software in any way, the Licensee accepts all the terms and conditions of this Agreement. If the Licensee does not agree with any of the terms or conditions of this Agreement, the Licensee has no right to install or use the Software and must delete all its components from the Licensee's computers.

This Agreement can be modified by the Licensor without any prior notice. The new edition of the Agreement goes into effect from the moment it is published on the Licensor's Website at the Internet address specified in this paragraph, if not otherwise provided in the new edition of the Agreement. The effective edition of the Agreement is always located on the Licensor's Website at the address:

1. Definitions

"Software" means the Blend4Web SDK Pro computer program, which is presented in an objective form as a set of data and commands including the source code, audiovisual pieces and documentation included by the Licensor as components of this computer program and intended for the functioning of computers and other computer devices with the goal of creating a certain result, including audiovisual pieces generated by this program and its description. The description of the Software is located on the Licensor's Website.

"Open Source Version of the Software" means the Blend4Web SDK Free computer program, which is distributed under the terms of the GNU General Public License version 3 (GPL v3), a copy of which is located and can be freely accessed at www.gnu.org/copyleft/gpl.html, and is not the Software itself or any of its components.

"Application" means any computer program or its components which were created by the Licensee's Designated Users or by the Licensee itself using the Software or its Modifications in accordance with this Agreement, provided that any such Application:

- 1) must have a substantially different functionality than the Software, and
- 2) must not allow any third party to use the Software or its Modifications, or any components thereof, for computer program development purposes.

"Designated User" means a distinct person (a developer of Applications), for whom the Licensee has purchased a license to use the Software, whether such person is an employee of the Licensee acting on the basis of an employment contract or a consultant or a contractor acting on the basis of a corresponding contract with the Licensee. A single license must be purchased by the Licensee only for one single

Designated User. If the Licensee needs to engage multiple developers, multiple licenses must be purchased according to the number of developers. An additional agreement must be made between the Licensee and the Licensor in which the information about the particular Designated Users, for whom the licenses are purchased, is specified. A Designated User can be replaced with a new Designated User only after 6 (six) months after the additional agreement is made.

“End User” means an individual that is the end user of the functionality of the Applications that were created by the Licensee and is not using these Applications for distribution, resale or software development purposes.

“Modification” means the result of any addition or deletion of the contents of the Software files or previous Modification files created by the Licensee, or the result of creating any new files that leverage any component of the Software or previous Modifications.

“Technical Support” means measures accomplished by the Licensor within the scope established by the Licensor for ensuring Software operation.

“Licensor’s Website” means the website with the *blend4web.com* domain name.

“Update” means a package of program components for the Software which are independent results of intellectual activity and are useful when they are used together with the Software.

2. License Grant

Subject to the Licensee's compliance with all the terms and conditions of this Agreement, and subject to the payment of the required fee, the Licensor, owning the exclusive rights to the Software, grants the Licensee a revocable non-exclusive non-transferable and non-sublicensable license (the "License") which empowers:

- 1) the Licensee or the Designated User (Designated Users) to use the Software to create Modifications and Applications;
- 2) the Licensee to distribute the Software and the Modifications to End Users solely as integrated into developed Applications;
- 3) the End Users to use the Software as integrated into the Licensee's Applications in accordance with the terms of this Agreement.

3. Intellectual Property and Trademarks

3.1. The Software (both its original version and the updated versions) and the Modifications are results of intellectual activity and are items of intellectual property (computer programs), which belong to the Licensor and are regulated and protected by copyright law of the Russian Federation and by standards of international law.

3.2. This Agreement does not grant the Licensee any rights to use the trademarks of the Licensor and/or the Licensor's partners.

3.3. The Licensee must not use the Software for performing any activities which are prohibited by law in the Russian Federation or by law of the country where the License is used.

3.4. The Licensee is fully responsible for all activities performed by the Designated Users while using the Software.

3.5. The Licensee or the Licensee's Designated Users are prohibited to distribute or transfer the rights to the Software and/or Modification, acquired by the Licensee in accordance with this Agreement, to any third party.

3.6. The Licensee is solely responsible for ensuring that the Licensee's Applications are in accordance with the current legislation, including the responsibility to third parties in cases when the Applications created by the Licensee or Licensee's Designated Users violate the rights and legitimate interests of third parties, including private non-property rights of authors, other intellectual rights of third parties, and/or encroach upon any intangible benefits.

3.7. The Licensee is aware of and agrees to the fact that the Licensee must independently evaluate the risks related to using the Software or its Modifications, including the evaluation of their reliability, completeness or usefulness.

3.8. The Licensee is not entitled to transfer the right to use the Software by means of a sub-licensing agreement.

3.9. The liability for intellectual property rights violation is governed by current law of the Russian Federation.

3.10. The Licensee is not entitled under any circumstances to remove or make hardly noticeable the information concerning intellectual property or trademarks or patent rights specified in the Software.

3.11. The Licensee gives the consent to publish the information about him as a client of the Licensor on the Licensor's website, as well as in informational, marketing and promotional materials and in other sources distributed by the Licensor, including the use of the Licensee's trademarks. The Licensor may also publish the information on collaboration with the Licensee (including articles, messages, in writing and audio-visual form), mention the Licensee as a client in media (online, offline, social media) and on advertising/marketing/educational products distributed by the Licensor among the general public, as well as at the events (conferences, seminars, webinars, exhibitions, corporate and business meetings).

4. Terms and Limitations of Software Usage

4.1. The Software or its Modifications can be used by the Licensee only for creating Applications for End Users; at the same time, these Applications must not contain any functionality which allows them to be used for creating other computer programs.

4.2. If the Licensee or any other third party creates an Application (Applications) or any of its components using the Open Source Version of the Software, the Licensee must not combine this Application (Applications) or any of its components with the Software, and must license such an Application (Applications) or any of its components under the terms of the General Public License (GPL).

4.3. The Licensee is required to ensure that the Software or its Modifications is not used with any applications other than those that the Licensee distributes in accordance with the terms and conditions hereunder. For example, if the Licensee installs the Software or its Modifications on a customer's (partner's, contractor's) server, the latter is not permitted to use the Software or its Modifications independently of the Licensee's Application, but only in conjunction with the Licensee's Application and must be informed of this by the Licensee.

5. License Fee

5.1. The amount of the license fee is specified on the Licensor's Website at www.blend4web.com/en/services/ and includes payment for the components of the License listed on the Licensor's Website.

5.2. The cost of Technical Support and Updates is included in the license fee defined in paragraph 5.1 of this Agreement. Technical Support and Updates are carried out by the Licensor over a period of 1 year starting from the date of this Agreement. Upon expiration of this period, the Licensee shall have the right to enter into an additional agreement, where the parties shall specify the cost, period and other terms of providing technical support.

5.3. The payment of the license fee can be made by money transfer to the bank account of the Licensor or by an electronic payment via the Licensor's Website; other payment methods are possible and can be agreed upon by the Parties separately.

5.4. The obligation to make the payment is considered fulfilled from the moment the funds are successfully transferred to the Licensor's bank account. Obligations to pay bank commissions in respect to the payment of the license fee shall bear either party under their mutual consent and shall be stipulated in an invoice for the license fee.

6. Technical Support

The Licensor provides Technical Support to the Licensee, including issues concerning the functionality and details of the installation and operation of the Software on standard supported configurations of operating systems, under the terms and conditions specified in paragraph 5.2 of this Agreement and in the "Services" section of the Licensor's Website at www.blend4web.com/en/services/.

7. Liabilities of the Parties

7.1. Violation of the conditions of this Agreement entails liability under the legislation of the Russian Federation.

7.2. The Licensor shall not be liable for any damage, loss of incomes or profits, loss of information or savings arising from the use or the inability to use the Software or its Modifications, including cases of being preliminarily informed by the Licensee of the possibility of such damages, or by a lawsuit from any third party.

7.3. Using the Software by the Licensee in a way which is not intended for in this Agreement, including illegal copying of the Software, or otherwise beyond the rights given to the Licensee in accordance

with this Agreement, leads to liability for violating the exclusive rights to the results of intellectual activities or to the means of individualization, under the legislation of the Russian Federation. When such cases are revealed from the side of the Licensee, the Licensor has the right to immediately terminate the Agreement without returning the license fee, and also to demand the payment of penalties and/or compensation of other damages, and to bring the Licensee to other measures of liability.

7.4. The Licensor does not provide any warranty with respect to the correctness and uninterrupted operation of the Software or its Modifications, including the cases where the failures in operation of the Software or its Modifications lead to liability of the Licensee to any third parties, or imposes administrative or fiscal liability.

8. Validity, Changing and Termination of the Agreement

8.1. This Agreement is made before or at the moment the Software starts to be used and is valid for the whole period of its legitimate use by the Licensee while the intellectual property rights for it are active subject to proper observance of the terms and conditions of this Agreement by the Licensee.

8.2. In accordance to the terms and conditions of this Agreement, the License can be used on the territory of the Russian Federation and other countries.

8.3. In case the Licensee fails to comply with the Software usage conditions of this Agreement, including but not limited to the terms of section 4 of this Agreement, the Licensor has the right to unilaterally terminate this Agreement, having notified the Licensee about this.

8.4. Upon termination of this Agreement by any party and for any reason, the Licensee must cease using the Software completely and destroy all copies of the Software installed on the Licensee's computers, including backup copies and all components of the Software.

8.5. In case a court of competent jurisdiction declares any of the terms and conditions of this Agreement invalid, the other terms and conditions of this Agreement continue to be binding.

9. Conclusion

9.1. Disputes and disagreements arising from this Agreement or because of it shall be resolved through negotiations between the Parties.

9.2. In case of a failure to achieve consent in accordance to the previous paragraph:

9.2.1. If the Licensee is a resident and/or a citizen of the Russian Federation, the Parties agree that all disputes and disagreements independently of their reasons, which arose or can arise between the Parties in accordance with this Agreement, including those related to its entering into, implementing, changing, terminating or annulling (in whole or partially), are submitted for consideration to the Moscow Court of Arbitration or to an applicable court of general jurisdiction or to a magistrates' court in accordance to the current legislation of the Russian Federation;

9.2.2. If the Licensee is an organization or another business entity without establishment of legal entity (partnership, joint venture etc) and is not a resident of the Russian Federation, or if the Licensee is an

individual and/or is not a resident or a citizen of the Russian Federation, the Licensee agrees that any dispute, disagreement or claim, which arises from or concerns this Agreement should be resolved in accordance to the rules of arbitration in the International Commercial Arbitration Court at the RF Chamber of Commerce and Industry (Moscow, Russia) (hereinafter ICAC) in accordance with ICAC regulations. The language in which arbitration proceeds is Russian. The decision of this court must be definitive and obligatory for the participating parties and is the only and exclusive method of resolving any disputes between the parties concerned.

The Licensor also reserves the right to apply for resolving a dispute to a court of competent jurisdiction in the location of the Licensee, taking into account the legislation requirements in the location of the Licensee, if the Licensor will wisely consider that this further allows to properly fulfill the resolving of the dispute within the applicable jurisdiction at the location of the Licensee.

9.3. This Agreement is regulated by the legislation of the Russian Federation independently of the jurisdiction of the examination of the dispute.

9.4. The Licensor does not transfer any additional rights or Software usage methods, which are not directly specified in this Agreement, to the Licensee.
